MISSION STATEMENT

The YMCA Corporate Games are designed to promote employee involvement in fitness and recreational activities intended to challenge the body and mind through the spirit of competition.

PROCEEDS

All proceeds generated from the Games will support the YMCA's Outreach Fund. This fund enables those who can't afford Y services to gain access to all of the facilities and programs the YMCA offers.

CORPORATE GAMES – WHAT IS IT?

The Corporate Games will feature six competitive events between businesses, industries, retail establishments, governmental entities and other interested organizations from the Jefferson City area. Each entity will have the opportunity to participate in a maximum of six events or a minimum of one.

Points will be awarded to the top 10 places in each event. If a team does not place in the top 10, then two participation points shall be awarded. The points accumulate throughout the Games, and the team that totals the highest number of points will be presented the "Corporate Games Cup" at the Closing Ceremony.

BENEFITS

1. Improve individual fitness/wellness.
2. Enhance company/organization pride.
3. Improve morale.
4. Access to the YMCA in July and August.
5. Build stronger working relationships.
6. Inspire camaraderie.
7. Fitness assessments provided.

EVENTS

All events will be coed. The event descriptions provide number of player's permissible, gender make-up and minimum number of teams. In the case the minimum number of team's criteria is not met, team captains will be notified and that particular event will be cancelled. The following events will be offered:

- A. Coed Kickball
- B. Coed Sand Volleyball
- C. Coed 2-Person Pickle Ball Tournament
- D. Coed 2-Person Corn Hole Tournament
- E. Coed Mystery Sports Competition
- E. Coed 2-Person Scramble Golf Tournament

KICKBALL

DATE: Saturday, July 8

LOCATION: 63 Diamonds-12143 Renz Farm Rd.

General Information and Game Rules

- A double elimination format will be used.
- Teams may have up to 18 players on their team roster. Ten players (five men, five women) will be on the field. Twelve players may be used (6 men, 6 women) if they choose to use "Extra Hitters" (EH).
- Each organization is allowed to have one team.
- Only one team is required to play for the corporation to participate.
- No additional alternates will be allowed after the tournament play has begun.
- Teams will be allowed to start the game with eight players (four men, four women). If the ninth and tenth players arrive during the course of the game, those two players may enter the game at that time (they may occupy any position on the field, but must be placed in the ninth and tenth spots on the batting order).
- The Game Captains reserve the right to change to an "Accelerated Count," if rain causes schedule delays. Accelerated Count: the batter begins with two balls and one strike. Each batter may receive a courtesy foul.
- No new games will begin after 12 midnight.
- Kick Balls will be provided.
- In the event of a tie an accelerated count will be implemented and a runner will be placed on second base to begin the inning. The visiting team begins the inning with two outs.
- Batting order must rotate between a man and a woman.

PICKLE BALL

DATE: Thursday, July 20 (Friday, July 21 if needed)

LOCATION: Firley YMCA – 525 Ellis Blvd.

General Information and Game Rules

- Pickle Ball will be Coed Doubles.
- The event will be a Double Elimination Tournament.
- A match will consist of one game to 21.
- Each company is allowed a maximum of four teams in this event.
- Only one team is required to play for the corporation to participate.
- Rules of the game will follow with the guidelines of the USA Pickle ball Association
- Matches will start Thursday evening at 5:30 p.m. with a cap at 10 p.m. If necessary, overflow will take place on Friday evening starting at 5:30 p.m.

Minimum number of teams-10

SAND VOLLEYBALL

DATE: July 29

LOCATION: Binder Sand Courts-5840 Rainbow Dr.

General Information and Game Rules

- A double elimination tournament format will be used to determine the overall champions.
- The team can consist of a maximum of 12 participants including alternates. The playing team must consist of three females and three males. A team not meeting the qualifications will forfeit.
- Each organization is allowed to have one team.
- Only one team is required to play for the corporation to participate.
- No additional alternates will be allowed after the tournament play has begun.
- Teams are expected to cooperate with match referees, game umpires and event judge. Only the volleyball event captain may dispute a call.
- The males and females must be positioned in an alternate format during play. When the ball is played more than once by a team, a female must make one of the contacts.
- Rally scoring will be used.
- A match will consist of the best two of three games.
- Blocking the serve is not allowed.
- There will be one time out allowed per team, per game. Extra time outs cannot be carried over to the next game or match. Time outs will be a maximum of 30 seconds.
- Server has five seconds to serve the ball after the service whistle has been blown. After each game, the teams will switch playing sides. The next game will begin within two minutes of previous game end.
- Each team is required to provide a line judge for their volleyball games.
- With the exception of these rules, USVBA rules govern all play.

CORN HOLE

DATE: Thursday, August 3 (Friday, August 4 if needed)

LOCATATION: Firley YMCA – 525 Ellis Blvd.

General Information and Game Rules

- Corn hole will consist of Coed Doubles.
- Each company is allowed a maximum of four teams in this event.
- Only one team is required to play for the corporation to participate.
- The event will be a Double Elimination Tournament.
- Matches will consist of one match to 25.
- Rules of the game will be rally scoring. (Each bean bag on the board counts as points). No cancelations.
- Matches will start Thursday evening at 5:30 p.m. with a cap at 10 p.m. If necessary, overflow will take place on Friday evening starting at 5:30 p.m.

Minimum number of Teams-8

MYSTERY SPORTS COMPETITION

DATE: Thursday, August 10

LOCATION: Location to be announced

General Information and Game Rules

- The mystery sports competition will be announced August 3.
- Each team must consist of two males and two females.
- Each company is allowed a maximum of four teams in this event.
- Only one team is required to play for the corporation to participate.

Minimum number of Teams-6

GOLF COED SCRAMBLE TOURNAMENT

DATE: Saturday, August 19

LOCATION: Oak Hills Golf Course

General Information and Game Rules

- Tournament is a two-person scramble.
- Golf teams consist of two players, one male and one female.
- Each company is allowed a maximum of three teams in this event.
- Only one team is required to play for the corporation to participate.
- Players select best location off the tee and continue to hit from the same spot.
- A team score will be recorded by hole and totaled at the completion of 18 holes.
- Any ball obstructed by a man-made hazard will receive a free drop.
- Repair divot and ball marks on the green.
- Keep carts 30 feet from tees and greens.

Minimum number of Corporations-15

Maximum number of teams-54

CLOSING CEREMONIES

DATE: Saturday, August 19 (immediately following golf tournament)

LOCATION: Oak Hills Golf Center and Downtown Businesses

- All participants are welcome to attend the closing ceremonies after the golf tournament at Oak Hills Golf Center.
- The Corporate Cup will be presented to the overall Top Scoring Corporation.
- Immediately following the closing ceremonies participants will be invited Downtown to celebrate.
- More details to come.

SCORING SYSTEM

Points shall be awarded in the following manner:

1 st	30 points
2 nd	24 points
3 rd	20 points
4 th	16 points
5 th	14 points
6 th	12 points
7 th	10 points
8 th	8 points
9 th	6 points
10 th	4 points
Below 10 th	2 points

The team accumulating the most points throughout the Corporate Games will receive the Corporate Cup. The Corporate Cup shall remain with the employer or association for one year. Each event will also have its own individual trophy for the winning team

COST

An entity may sign up for a maximum of six events. However, an entity may sign up for only one event if so desired. Listed below is the participation cost options (*YMCA Corporate Groups receive a \$50 discount!*):

Participation in:

- 6 events: \$700
- 5 events: \$600
- 4 events: \$500

Participation in fewer than three events:

\$150 per event.

ENTERING MORE THAN ONE TEAM AS A CORPORATION

Companies may enter more than one team into the competition. If a company enters more than one team, they will not be able to share participants between teams. For instance if the YMCA wants to put two teams into the games, each team will have their own Identification and unique roster.

WELLNESS ASSESSMENTS

Free wellness assessments will be offered for before and after the games. A wellness assessment is a 5 minute assessment with an exercise specialist that includes the following:

- Inbody Assessment
- Grip Test
- Blood Pressure

GENERAL INFORMATION

- **Communication**

The Jefferson City Area YMCA will communicate exclusively through the company coordinator. Employees should direct all questions concerning the Jefferson City Area YMCA Corporate Games (JC YMCA CG) to their company coordinator.

- **Games Booklet – Schedule of Events**

Company coordinators will receive the Corporate Games Booklet containing all final event schedules by June 1st. Event times may be approximate and can vary slightly due to weather and/or unanticipated delays in the event schedule.

- **No Rescheduling of Games**

In the event of inclement weather and unpredictable circumstances, every attempt will be made to reschedule any competition that may be affected.

- **No Forfeits, Please**

Once you receive your Corporate Games Booklet, please make sure entrants in each event are notified of the game times and location. A forfeit not only upsets the scheduled event, but also takes away from the spirit and competition of the games. Please emphasize to your employees that by signing up for an event, they are making a commitment to be there. Not showing up for an event shall be counted as a loss or elimination.

- **Helpful Hints**

The following have been helpful for other events of similar nature:

- Identify an enthusiastic person to be your company coordinator.
- Sub-divide and have event captains for each event.
- Post information in your lounges and lobbies.
- Provide incentives for participation
- Develop inner-company pride.
- Uniformed shirts reflect strong company pride.

COMPANY ELIGIBILITY

1. There is no maximum limit of team members.
2. Team members must be 18 years of age.
3. Team members must be employed by the registered company or verify membership with a specific association. Employment is defined as full-time or part-time.
4. Retired employees of participating companies may participate with their former employer.
5. Participants must complete all necessary forms: Employee Participation Form and Liability Waiver.
6. Individuals, other than those participating with a company, may enter the competition provided they form teams as representatives of professional or religious groups (e.g. Medical Society, Auto Dealers, Bar Association, Rotary Club).
7. Participants may participate with only one company.
8. The Jefferson City Area YMCA reserves the right to review all team entries relative to eligibility.
9. There are no restrictions on how many events an individual may do.
10. The Company Coordinator must complete the following forms: Employer Information and Participation Form and the Corporate Games Event Roster Form.
11. The participant must complete the Employee Participation and Liability Waiver Form.
