CORPORATE GAMES – WHAT IS IT?

The Corporate Games feature eight competitive events between businesses, governmental entities, and other interested organizations from the Jefferson City area. Each entity will have the opportunity to participate in a maximum of eight events or a minimum of one. Events are scored and teams accumulate points. The team accumulating the most points will win the Corporate Games Cup

MISSION STATEMENT

The YMCA Corporate Games are designed to promote employee involvement in fitness and recreational activities intended to challenge the body and mind through the spirit of competition.

PROCEEDS

All proceeds generated from the Games will support the YMCA's Outreach Fund. This fund enables those who can't afford Y services to gain access to all the facilities and programs. It also supports LiveSTRONG at the YMCA which is a 12-week program designed to help adult cancer survivors regain strength, work on health goals and gain connections. In addition, Veterans receive a two-month membership while they take part in VA's Whole Health program and learn the components of proactive health and well-being..

1. Improve individual fitness/wellness.
2. Enhance company/organization pride.
3. Improve morale.
4. Access to the YMCA in July and August.
5. Build stronger working relationships.
6. Inspire camaraderie.

HELPFUL HINTS

The following have been helpful for other events of similar nature:

- Identify an enthusiastic person to be your company coordinator.
- Sub-divide and have event captains for each event.
- Post information in your lounges and lobbies.
- Provide incentives for participation.
- Develop inner-company pride.
- Uniformed shirts reflect strong company pride.

FRISBEE GOLF

DATE: Saturday, July 12

LOCATION: Binder-5840 Rainbow Dr.

General Information and Game Rules

- Tournament is a two-person scramble.
- Golf teams consist of two players, one male and one female.
- Each company is allowed a maximum of three teams in this event.
- Only one team is required to play for the corporation to participate.
- A team score will be recorded by hole and totaled at the completion of 18 holes.
- Any ball obstructed by a man-made hazard will receive a free drop.

TRIVIA

DATE: Monday, July 14

LOCATION: Last Flight Brewing-738 Heisinger Rd.

General Information and Game Rules

- Trivia will consist of teams of 5.
- Teams will be allowed any variations of Male and Female.
- Each corporation will be allowed 2 teams.
- Trivia will be 6 rounds with random topics chosen by Last Flight
- Each round will be an accumulation of points.

CORN HOLE

DATE: Monday, July 21

LOCATION: Downtown Location TBD

General Information and Game Rules

- Corn hole will consist of coed doubles only.
- Each company is allowed a maximum of 3 teams in this event.
- Only one team is required to play for the corporation to participate.
- The event format will be decided depending on the amount of teams entered.
- Rules of the game will follow the Official Rules of Mid Mo Corn Hole.

3v3 BASKETBALL

DATE: Thursday, July 24

LOCATION: Firley YMCA – 525 Ellis Blvd.

General Information and Game Rules for Basketball

- There will be Men's and Women's divisions.
- Games will be two 11-minute halves.
- Specific in game rules that pertain to fouls and game procedure will be discussed in detail in the Game Packet.
- Points will be scored 1 point for inside the 3pt line, and 2 points for outside the 3pt line.
- Each team to have a minimum of 4 players.
- Each company is allowed a maximum of 2 teams per division.
- Only one team is required to play for the corporation to participate.

SAND VOLLEYBALL

DATE: Friday, August 1

LOCATION: Binder Sand Courts-5840 Rainbow Dr.

General Information and Game Rules

- A double elimination tournament format will be used to determine the overall champions.
- The team can consist of a maximum of 12 participants including alternates. The playing team must consist of three females and three males. A team not meeting the qualifications will forfeit.
- Each organization is allowed to have one team.
- No additional alternates will be allowed after tournament play has begun.
- The males and females must be positioned in an alternate format during play. When the ball is played more than once by a team, a female must make one of the contacts.
- Rally scoring will be used.
- A match will consist of the best two of three games.
- Blocking the serve is not allowed.
- There will be one time out allowed per team, per game. Extra time outs cannot be carried over to the next game or match. Time outs will be a maximum of 30 seconds.
- Server has five seconds to serve the ball after the service whistle has been blown. After each game, the teams will switch playing sides. The next game will begin within two minutes of previous game end.

PICKLEBALL/RACQUETBALL

DATE: Thursday, August 7

LOCATION: Firley YMCA – 525 Ellis Blvd.

General Information and Game Rules – Pickleball

- Pickle Ball will be Men's and Women's
- The event will be a Round Robin/Single Elimination Tournament.
- A match will consist of one game to 21.
- Each company is allowed a maximum of 4 teams in this event.
- You are not restricted to the amount of teams in a single division.
- Only one team is required to play for the corporation to participate.
- Rules of the game will follow with the guidelines of the USA Pickle ball Association.

General Information and Game Rules – Racquetball

- Racquetball Men's and Women's Divisions.
- Each Division will play Singles (1v1).
- The event will be a Double Elimination Tournament.
- A match will consist of 1 game to 21.
- Each company is allowed a maximum of 2 people per division.
- Only one participant is required to play for the corporation to participate.
- Rules of the game will follow with the guidelines of the USA Racquetball Association.

DODGEBALL

DATE: Thursday, August 14

LOCATION: Firley YMCA – 525 Ellis Blvd.

General Information and Game Rules

- Divisions will be Co-Ed.
- A double elimination tournament format will be used to determine the overall champions.
- Each game will be a best 2 out of 3 games with a time limit of 10 minutes per game.
- Each team will have a minimum of 6 players with a maximum of 10.
- Rules will follow the USA Dodgeball guidelines.
- Each company will be allowed 2 Teams.

FIELD DAY

DATE: Saturday, August 16

LOCATION: 63 Sports Complex – 12610 Renz Farm Rd.

General Information and Game Rules

- Each Corporation will have 1 team with a minimum of 8 participants
- These teams will be Co-Ed
- Corporations will compete in 5 games. 1 double elimination, 4 at own pace.
- Punt Pass and Kick
 - Each corporation will have 3 guys 3 girls.
 - Top male and top female per corporation will be ranked.
- Mystery Challenge.
- Soccer Shoot Out.
 - Each corporation will have 3 guys 3 girls.
 - Top male and top female per corporation will be ranked.
- Tug of War (8v8) Co-Ed 4 guys 4 girls.
- Crazy Relay Race. (6 participants, 3 guys 3 girls) Co-Ed Relay will consist of:
 - Wheel Barrel Run – 1 Participant pushing 1 Participant in a wheel barrel.
 - Sack Race – 1 Participant in a Sack.
 - Three Legged Race – 2 Participants tied together at the leg.
 - Sprint – 1 Participant running forward.

CLOSING CEREMONY

DATE: Saturday, August 16 (Immediately following Field Day)

LOCATION: 63 Sports Complex

- All participants are welcome to attend the closing ceremonies at the Field Day.
- The Corporate Cup will be presented to the overall Top Scoring Corporation.
- Immediately following the closing ceremonies participants will be invited Downtown to celebrate.
- More details to come.

One Point will be given to any team that shows up and does not place. If any corporation takes multiple places in the same division, you will be rewarded your highest point total and all other teams will receive 1 point. For example: If the YMCA takes 1st through 3rd in corn hole, They will receive the point Total of 32 points. 30 for 1st place. 1 point for second, and 1 for 3rd.

The team accumulating the most points throughout the Corporate Games will receive the Corporate Games Cup. The Corporate Games Cup shall remain with the employer or association for one year. Each event will also have its own individual trophy for the winning team

Points will be awarded to the top 10 places in each event/division. If a team does not place in the top 10, then 1 participation points shall be awarded. The points accumulate throughout the Games, and the team that totals the highest number of points will be presented the "Corporate Games Cup" at the Closing Ceremony.

COST

An entity may sign up for a maximum of eight events. However, an entity may sign up for only one event if so desired. Listed below is the participation cost options:

Participation in:

- 8 events: \$1000
- 7 events: \$875
- 6 events: \$750
- 5 events: \$625

Participation in fewer than 5 events:

\$150 per event.

ENTERING MORE THAN ONE TEAM AS A CORPORATION

Companies may enter more than one team into the competition. If a company enters more than one team, they will not be able to share participants between teams. For instance if the YMCA wants to put two teams into a competition such as Sand Volleyball, each team will have their own Identification and unique roster.

GENERAL INFORMATION

- **Communication**

The Jefferson City Area YMCA will communicate exclusively through the company coordinator. Employees should direct all questions concerning the Jefferson City Area YMCA Corporate Games (JC YMCA CG) to their company coordinator.

- **Games Booklet – Schedule of Events**

Company coordinators will receive the Corporate Games Booklet containing all final event schedules by June 1. Event times may be approximate and can vary slightly due to weather and/or unanticipated delays in the event schedule.

- **Rescheduling of Games**

In the event of inclement weather and unpredictable circumstances, every attempt will be made to reschedule any competition that may be affected.

- **No Forfeits, Please**

Once you receive your Corporate Games Booklet, please make sure entrants in each event are notified of the game times and location. A forfeit not only upsets the scheduled event, but also takes away from the spirit and competition of the games. Please emphasize to your employees that by signing up for an event, they are making a commitment to be there. Not showing up for an event shall be counted as a loss with a deduction of 5 points per team entered.

COMPANY ELIGIBILITY

1. There is no maximum limit of team members.
2. Team members must be at least 16 years of age.
3. Team members must be employed by the registered company or verify membership with a specific association. Employment is defined as full-time or part-time.
4. Two companies may join to form a team as long as they do not exceed 30 Employees combined. For instance if the YMCA has 20 employees and Midwest Block has 7 employees, they may join together to compete
5. Retired employees of participating companies may participate with their former employer.
6. Participants must complete all necessary forms: Employee Participation Form and Liability Waiver.
7. Individuals, other than those participating with a company, may enter the competition provided they form teams as representatives of professional or religious groups (e.g. Medical Society, Auto Dealers, Bar Association, Rotary Club).
8. Participants may participate with only one company.
9. The Jefferson City Area YMCA reserves the right to review all team entries relative to eligibility.
10. There are no restrictions on how many events an individual may do.
11. The Company Coordinator must complete the following forms: Employer Information and Participation Form and the Corporate Games Event Roster Form.
12. The participant must complete the Employee Participation and Liability Waiver Form.
